Construction Overnight Parking Permit

Garden City Code 10-1-3 A7 No Person in any park shall: Leave a vehicle standing or parked after closing hours of the park.

VEHICLE RESTRICTIONS

- Construction Overnight Parking Permit will be issued in conjunction with a Construction Use License or with a Parks Construction Contract.
- All vehicles, (i.e. cars, trucks, trailers) parked on overnight in a park, regardless of use, must have a vehicle permit displayed, cars & trucks in the front windshield, trailers taped to the top of the trailer on the tongue side. Permit must always be visible from the outside the vehicle.
- Vehicles parked overnight must be an active part of the construction project.
- Garden City Parks reserves the right to limit the size and number of vehicles in a park associated with a project
- The permit will identify the vehicle, license number, size and weight of vehicle, purpose for parking overnight, park facility, date and time.
- A Vehicle Permit does not allow any person to set up camp, tents, or any temporary shelter, or to use house trailers, campers, motorhomes or automobiles for the purpose of overnight camping in any city park between sunset and sunrise.
- Any vehicle or trailer parked on park property without a Permit will be towed.
- Vehicle Access/Overnight Permits require no less than 48 hours to process.
