PURSUANT TO ESTABLISHED PROCEDURE, NOTICE IS HEREBY GIVEN that there will be a public (neighborhood) meeting held, Thursday, November 17, 2022, from 5:30 p.m. – 7:00 p.m. to discuss proposed changes to the following: CPAFY2022-0004 Accessory Dwelling Units; CPAFY2022-0006 Parking; CPAFY2023-0001 Sureties; and CPAFY2023-0002 Extensions. The City of Garden City is proposing that the city code be amended to improve parking regulations, update guidelines for accessory dwelling units, modify surety requirements, and ensure permit extension timelines are uniform. The purpose of these amendments will be to improve Title 8 for both developers and the City, to make the codified ordinances more uniform and objective, and to ensure the City code aligns with the purpose of Garden City's Comprehensive Plan. The changes may include, but are not limited to, amendments to Garden City Code 7-1-6; 7-1-7; 8-2C; 8-3D; 8-4C; 8-4D; 8-4F-4; 8-4G; 8-4I; 8-4J; 8-5B; 8-5C; 8-6A-8; 8-6B; and 8-7A.
