Hi

I got a letter from ALC Architecture in Eagle. Foothills Church wants to put in three portable classroom buildings on their site. The school (Ambrose) that uses their building is expanding. I think that they need a traffic study before approval. The north entrance to the church is way too close to State Street and causes issues at morning start of school and afternoon pick up. Also the church services on Sunday cause issues. If they expand it's only going to get worse. In addition to the problems at the State/Ulmer intersection, there will be more traffic down Ulmer and Heceta Head to get to the light at Old Horseshoe Bend and State. I understand that they have not formally submitted anything to the City, but I think you should require an ACHD study when they do.
