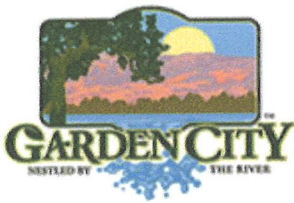

YOU ARE HEREBY NOTIFIED as an interested party that an appeal hearing will be held before the Garden City Hall, Council Chambers located at 6015 N. Glenwood St., Garden City, ID 83714:

- (1) on the **23<sup>rd</sup> day of October, 2023 at 6:00 pm**, the City Council will decide whether to consider the appeal; and
- (2) if the City Council moves to consider the appeal, it will be set for a non *de novo* hearing appeal on the **13<sup>th</sup> day of November, 2023 at 6:00 pm**.

The hearing is to be held pursuant to **Section 8-6A-9 of the Garden City Code**. The decision and determination made by Staff, based on the recommendations of the Design Review Consultant(s), relative to the application and interpretation of the Garden City Code Title 8, has been appealed.
